This bulletin also contains information about a version change to some forms to amend the form locations for Intranet users.

In line with our procedures to ensure faster access to updated forms, you may already have installed some of these latest versions.

IMMIGRATION – FOR IMMEDIATE USE

The following forms are now available for immediate use. In line with Rule 34Y of the Immigration Rules, *where an application is made no more than 21 days after the date on which a form is specified (within the meaning of paragraph 34) and on a form that was specified immediately prior to the date of the new specification, the application is deemed to have been made on the specified form (and is therefore not to be treated as invalid by reason only of being made on the “wrong” form).*

PBS(DEP)15 should no longer be used and has been withdrawn to avoid accidental use.

Wait for the reset to complete and then restart Laserform Intranet. Laserform Desktop users do not need to do anything in addition to installing the updated forms.

As a matter of housekeeping, the forms have been updated in both Laserform Intranet and Desktop to ensure consistent version numbers; the date stamps remain the same.
